Course Description & Syllabus

This course is written to present some of the essential foundation stones and building materials necessary for the New Testament Church to fulfill its mission. Today, the need to enhance one's awareness and effectiveness for building an apostolic pattern exists. This course is designed to provide enrichment through practical applications that enhance the life of every believer, leader, and their ministry teams. As there are always traditional barriers to the new things that God does, so there is ongoing resistance to the full function of the five-fold ministry in the Church. Some of this is understandable, as every new thing that God wants to restore arrives on the scene in a less-than-mature form and expression. Because we carry the divine anointing in human vessels, our ministry typically manifests weakness and error along with the glory and the power. This is to be expected. The good news is that God is patient, determined and committed to us and His purposes. He is drawing His bride to Himself and steadily building His glorious Church, as only He can.

This course can be taken on an undergraduate level of study (B201 - toward a Bachelors degree), or it can be taken on a graduate level of study (B501/B701 - toward a Masters or Doctors degree), providing the course requirements are met as explained in this course syllabus.

OBJECTIVES:

ACADEMIC--- To enable the student to gain a basic knowledge and understanding of the importance of the ministry of the apostle to the Church universal.

ATTITUDINAL--- To conceptualize an awareness and understanding of the office of the five-fold ministry and their relevance to the modern church today.

BEHAVIORAL--- To help the student engage in diverse practical applications of the characteristics, functions, and structure of the office of the apostle as one participates in the building of an effective New Testament church and/or ministry.

B201 - (DIPLOMA – ASSOCIATE - BACHELOR) – 3 CREDIT - DEGREE REQUIREMENTS

For Students taking this course as an undergraduate, (4) credit course, an additional six (6)-page essay is required to be submitted on the subject of: How is/can your ministry positively impact the Kingdom through your efforts in doing team ministry? This six (6)-page essay includes a cover page & bibliography page. The essay is to be typed double spaced, in New Times Roman type font, 12 font size. The instructions for essay/assignment submission are as follows: Coursework may be electronically uploaded into the Online Student Portal (if taking the course as an Online Student); submitted to the overseeing Instructor (if taking the course as part of a Distance Learning (DLC) Center); or electronically emailed to Assignment@chesapeakebiblecollege.com.

1. Maintain a minimum of a "C" average for the course.
2. Read all materials assigned.

3. Study the review materials.
4. Before taking the final examination, *the student will submit a minimum four-page reflection response essay which answers any three (3) possible reflection questions as outlined as part of Appendix 1 (Extra Study by Chapter Reflection Questions)*. This will constitute one-half (50%) of your grade for the course. Outlines submitted must have course title page and may be submitted as outlined in the B201 Degree Requirement description above.
5. Successful completion of the Mid-term (25%) and Final (25%) Examinations will constitute the remainder of your grades for the course.

B501 - (MASTERS) – 4 CREDIT - DEGREE REQUIREMENTS

For students taking this course on a Master's level, the student must:

1. Maintain a minimum of a "B" average for the course.
2. Read all materials assigned.
3. Study the review materials.
4. Before taking the final examination, the student will submit a ten (10)- page essay on any topic pertaining to the subject studied in this course. This ten (10)-page essay includes a cover page & bibliography page. The essay is to be typed double spaced, in New Times Roman type font, 12 font size. The instructions for essay/assignment submission are as follows: Coursework may be electronically uploaded into the Online Student Portal (if taking the course as an Online Student); submitted to the overseeing Instructor (if taking the course as part of a Distance Learning (DLC) Center); or electronically emailed to Assignment@chesapeakebiblecollege.com. The essay will constitute one-half (50%) of your grade for the course.

Appendix 1 - Extra Study by Chapter Reflection Questions

2. From the list of twelve "foundation stones," choose any three of those foundation stones and, in your own words, describe what they mean to you.
3. How would you handle a person who comes to you declaring that he believes he deserves a position on the staff of your church. (This exercise assumes you are the pastor.)
4. Regarding Relationships and the Church – describe how or whether you see the concept of covenant operating within your church and/or ministry.
5. Terry Edwards talks about "equipping the saints" from Ephesians 4:12. In your

own words, explain why this is necessary.

6. Dick Benjamin talks about "body ministry". In your own words, tell what that term means to you, and tell whether it is encouraged in your church or ministry.

7. Dick Iverson talks about the five-fold ministry. In your own words, describe why you agree or disagree with his belief that the five-fold ministry should operate in the Church today.

8. In Lesson 8, Dick Iverson talks about team ministry. From what you have read, describe whether this concept is operational in your church or ministry.

9. From Lesson 9, describe which one of the three leavening agents have you or someone you know encountered.
